Minutes of 2004 AGM.
No comments on 2004 minutes. General consensus
on background notes was that they are useful but too
long.

Treasurer's Report.
The treasurer's report and draft account for year
ending Dec 31st 2004 were circulated and accepted.

Main points were that membership is down to just
over 200 despite efforts to promote Pedals, and that
Pedals relies very heavily on income from
publications.

Election of Officers.

The current four serving officers were re-elected.
Peter Osborne agreed to become Minutes Secretary.
This still leaves the posts of secretary, social
secretary and newsletter editor vacant.

March Monthly Meeting: Other stuff:

The 25th anniversary meal was a success. It was
suggested that something similar be arranged,
possibly for Jan 2006.

Clear Zone (the main cycle route East-West through
the city centre) was discussed. A number of
councillors are sympathetic towards cycling and it
was suggested that Pedals should do more to
cultivate and lobby councillors.

Roger Codling reported back on the **Broxtowe**
transport meeting.

Publicity Flyer.

This is to be halfway between a newsletter and
membership form, and produced to a high standard.
It should be in addition to the three times a year
newsletter and be available for direct distribution to
bikes/ cyclists and libraries etc. The 10% discount for
Pedals members in various bike shops should be
emphasised.

The Big Wheel.

It was felt that they are not doing enough for cycling.
Pedals is doing its own launch of City, County, Forest
as there is no help from the Big Wheel.

Finance.

Pedals affiliates to the CTC at £25 a year. This
increased to £75 a year from October 2004. Pedals
already pays £195 a year for a separate insurance
policy. Agreed to write to the CTC saying that their
new arrangements for affiliated groups did not suit
us.

Newsletter.

This already has a featured cyclist. Alistair is writing
an article about Boost.

Beechdale Road.

Currently undergoing major improvements. Ideas
have been solicited from Pedals on cycling provision.

CCN

Andrew Martin has been nominated as Pedals rep for
this. Pedals, membership of CCN is to be renewed.
And it was agreed to join the new CCN Company.

NEP Helmets. campaign

The Nottingham Evening Post is currently pushing a
big campaign promoting the compulsory wearing of
cycle helmets. Hugh and Lawrence have drafted a
letter to the Post's editor. This was read out and has
also been circulated by email.

Safety.

It was reported that cyclists leaving their bikes in the
city centre have had them interfered with and left in a
potentially dangerous state. In particular cyclists
should check their brakes and wheel nuts.

Update:

NEP Helmets Campaign

My letter to the NEP was eventually published, on 1 April (and not as an April fool), to be followed a few days later by one from someone else saying that he agreed with me that cyclists should not necessarily wear helmets; the people that did need them were pedestrians to help them cope with the menace of cyclists on pavements!

Meanwhile it seems that our efforts to lobby the County Council to drop the requirement for GNBR participants to wear helmets may have been successful. This is not being required this year and an NEP article implied that this was because of Pedals stance opposing it.

Doctor Bike: message from Julie Pescod of GlobalActionPlan (passed on to Peter Osborne to respond to)

"Dear Hugh

I have just been looking at your website and I am interested in finding out more about your Dr Bike sessions. Can you tell me if run these just at events? At the moment we are looking to deliver the EcoTeams programme on Broxtowe Estate as well as other parts of Nottingham City. In the Transport part of the EcoTeam programme I was thinking that it may be useful for residents to have the opportunity to have their bicycles checked over by you.

We are hoping to work with a number of residents (our target is 100) which means that we will have about 16 teams over the next two years. Of course I am not expecting you to come along to 16 sessions but I was thinking that maybe we could have a transport morning or afternoon with yourselves and maybe Ridewise (I have yet to contact them).

8. Local Transport Plan consultation

I will report at the meeting on the outcome of the special subgroup meeting on Monday 11 April. Thanks to Andrew Martin, Alistair Morgan and Roger Codling who came to this. I will now do a further revision before our meeting on Monday. I have taken up a suggestion from Lawrence to restructure the submission with a) the general comments going in a covering letter and b) then 2 detailed "wish lists", for both City and County Council areas separately.

Our comments need to be finalised by 29 April.

Pedals comments on Local Transport Plan submissions: comments from Susan Young (8 April)

Hugh

I agree with Paul about Toucan crossings at Bluecoat Island - very difficult at the moment without a significant detour on the Aspley side. Crossing Aspley Lane by David Lloyd is really hard for both cyclists and pedestrians.

Also more on road facilities as there are limitations to cycle tracks, especially as they often end at junctions leaving those new to cycling especially perplexed as to what to do next.

There is also the issue, especially noticeable along the ring road of the huge number of drives etc which cross the path. It is often very difficult to clearly see if cars are emerging and they are often so busy concentrating on getting on or off the main road that the cycle track is ignored.

There are also a number of side roads off the track at acute angles making it very difficult to see traffic approaching or ride smoothly. A number of cycle tracks seem to be built with leisure cyclists in mind rather than those using cycles as transport.

The splitting of those who cycle into path users v road users does none of us a favour as it causes perceived and real conflict as to where we should be - on paths or roads. I more and more feel that unless a cycle path is going to enhance the type of journey it is most likely to be used for, don't bother, but look to helping cyclists across junctions with ASLs and getting across roads by the use of Toucans.

It's a difficult one where we have those cycling for leisure and those who want to get from A - B quickly and easily.

9. Cyclists' Manifesto and General Election Lobbying

With the general election now called, CTC has launched a Cyclists' Manifesto with support from the London Cycling Campaign and the Cycle Campaign Network. It sets out the actions which it is believed are needed to revitalise the National Cycling Strategy, with its original target to quadruple cycle use over 16 years.

The manifesto calls for:

1. Better cycling conditions

- Introduce a default 20 mph speed limit for most urban and residential streets
- Require local authorities to adopt procedures to assess and overcome barriers to cycle accessibility (e.g. busy roads, major junctions), and deliver quality cycle networks in their areas

2. Better funding for cycle training and promotion

- provide dedicated revenue funding for "soft measures" such as cycle training, direct marketing (e.g. the TravelSmart initiative) and promotional activities such as Bike Week, European Mobility weeks and the TravelWise campaign.
- Provide fiscal incentives, e.g. removal of VAT from cycle, cycling equipment and cycle-related services (such as cycle training courses)

3. Better traffic laws and policing

- revise the law on driver's insurance to make it easier for non-motorised users to claim injury damages from drivers who hit them
- make traffic policing a Core Priority in the National Policing Plan

4. Better integration of cycling and wider transport objectives

- treble the number of rail trips which also involve cycle travel as part of the journey
- promote road safety awareness campaigns in ways which encourage increased cycling

5. Better integration of cycling across all areas of Government

- maximise cycling's contribution to health, education and environmental objectives (including tackling climate change), and enlist support from the health, education, retail, tourism and other sectors towards the growth of cycling.
- Provide more resources to promote off-road, sports and other recreation cycling (including 'Quiet Lanes', 'Greenways', 'Rediscovering Lost Ways' and other existing Countryside Agency initiatives)

We have been asked to find out which of these proposals our actual or would-be political representatives will be willing to support in the new parliament. and to record candidates' answers, so that these results can then be followed up.**

10. NET matters

Depending on the result of the County Council elections in May and the implications of this for continuing support for the development of the two proposed extension lines we need to be ready to start pressing the case for allowing bike access in future, at least on the new lines and, in due course, on Line One, with retrofitting and likely refurbishment etc. in due course.

11 (other) cycle facility and traffic matters)

Copy of message of 25 March to Steve Brewer re The Turning Point from Arthur Williams (past Pedals activist)

"Dear Steve,
As an employee of Nottingham Trent University and a regular cycle commuter, I am concerned about the developing road system under the turning point scheme and its effect on staff and students of NTU. There seems to be very little provision for cyclists to use the main routes through the scheme, and connections to quieter routes are being cut off.

For example, if one wishes to leave the City campus and travel towards the east, north-east or north part of the city, there is no longer access for cyclists from Shakespeare Street into the bottom of Sherwood Street, at the corner of the new Mechanics Institute building. This, surely, would not have been difficult to integrate within the scheme, without effecting pedestrian access significantly. Also, the exit from Shakespeare Street into the main traffic flow at the same junction, is so narrow that cyclists have to wait for cars queuing at the give way lines. An advance stop line for cyclists would not help, as at rush hour they would not be able to reach it.

In general, the junctions seem to have been designed with little space for cyclists. If the City is serious about encouraging commuters onto their bikes, it looks as if some important changes need to be made to improve the current scheme.

I would welcome any comments that you have, and would be willing to look at detailed plans to see what can be done.

PS. I have checked this on site and it seems that a cycle gap is being included at the bottom of North Sherwood Street so that cyclists can ride into Shakespeare Street. However there will not be any legal way to continue into the new bus and cycle lane southbound on South Sherwood Street, something that we challenged when I saw the plans early last year and which, we were told, would be impossible without making difficult the planned pedestrian phases in the new signal arrangements at this junction.

Clear Zone changes: cycle gap at St. Peter's Square: copy of my message of 6 April to Steve Brewer and Polly Brant, City Council

" Steve, Polly

I know that work is still not yet complete on the revamp of the road closure at St. Peter's Square but from what I have seen of the work so far it is not obvious where the promised cycle gap, including dropped kerbs, is going to go, unlike in the temporary scheme where there was a clear gap.

Is this indeed going to be clearly provided for and indicated in the final scheme? This does need to be clearly indicated as indeed does all the route that cyclists should take from the Castlegate / Maid Marian Way toucan crossing through to the Old Market Square now that the No Entry signs on St. Nicholas Street are to be put back.

Sneinton Market Pedestrian Priority route:

I forgot to mention this at our last meeting, having received a letter just before the meeting on which I have sent in some comments.

Broken glass: copy of message of 5 April from Paul Hill:

"Dear Hugh and Waste Management Team
Noted today there is broken glass from beer bottles once again on the slope at Raleigh Island - northbound side i.e. the approach to Radford Bridge Road. Hard to avoid and nearly cost my friend his new tyres on his brand new bike which he only collected today. Which would have meant a long walk home. Luckily we managed to avoid the glass and before any damage was caused. Other cyclists might not be so lucky!

Also crushed glass on the curve at Nuthall Road (northbound side) at Spud Island, on the cycle way approaching Trade Interiors.

To the WMT, please arrange for the glass to be removed from these areas as a matter of urgency, before a cyclist ends up with a bill for new tyres and having to sue the council for compensation. Meanwhile, please confirm that you have arranged for this to be done. We shall be round there within the next week to inspect the areas mentioned. Hope you will take these areas into account when carrying out the Annual Spring Clean, which should really be each week, not annually.

Can the Waste Management Team explain why cyclists in this city are given a low priority when it comes to street cleaning, i.e. not keeping cycle paths free from all manner of litter.

To the Evening Post, the above problem is exactly what cyclists are complaining about in the press recently.
